Machinists Union Organizing Local Membership Drive MNCTDA to Hold Special Workshop, Wednesday, April 24

s reported in a "Special Bulletin," faxed to all WANADA dealer members on April 11, the International Association of Machinists (IAM) is actively trying to recruit new members from the ranks of auto technicians throughout Maryland and DC. Pairs of IAM reps have been particularly active in Montgomery and Prince George's Counties recently, speaking with dealership technicians and leaving invitations to a union meeting held at the Holiday Inn in Laurel, MD last Sunday, April 14.

In response to this recent IAM recruitment drive, MNCTDA will be conducting a special "Union Activity Seminar" at the BWI Airport Marriott, Wednesday, April 24, 10:00 a.m – 12:00 noon. The seminar, reported in a follow-up notice faxed to

NADA to Hold Election for Director for Metro D.C.


Geoff Pohanka Stands for Reelection

On May 3, NADA will be mailing nomination ballots to all Washington area NADA members in good standing to elect a NADA Director for Metropolitan Washington, D.C. The ballots must be returned by May 24.

Geoff Pohanka, who is serving out the term of retired Metro D.C. Director Lou Kairys, has said that he will seek the office for his own three-year term.

Candidates must receive 10 percent of the total votes cast to qualify as a nominee. Should only one qualified nominee agree to serve if elected, then the nominee shall be declared elected without further balloting.

The director elected or reelected from Metro Washington will be



seated at the second NADA board meeting held in conjunction with the NADA Convention, February 1-4, 2003, in San Francisco.

Details on the nomination process will be included with the ballots sent out from NADA.

Board (NLRB) for an election to be held at dealerships in Prince George's County and Baltimore. Those petitions were withdrawn in January 2001 for an apparent lack of support among technicians for union memberships. However, with headquarters in Prince George's County—but no union representation in the county's auto dealerships—the IAM has renewed its efforts to recruit auto technicians.

The union is pitching techs on how they can gain higher wages and better benefits, job security, fairness on the job and good pensions through IAM membership. Employers, therefore, need to know what to do and not do to counter the union and not violate the labor law. Here are some pointers:

- Employees have a right to organize in a union under federal law and this right can't be limited by "unfair labor practices" by the employer. An example here would be an employer "spying" on or trying to sneak into a duly organized labor union meeting such as the one that occurred last weekend.
- If (when) organizers come onto the dealer-

ship property to hand out or drop leaflets, don't over react – simply ask them to leave. If they persist, particularly if they're in "employee only" areas or disturbing the peace, call the police. Make sure no literature is lying around on the floor or other public areas.

- If the organizers offer you paper or "enrollment cards" to examine, don't accept or touch them. To do otherwise has been interpreted by the courts to have commenced union negotiations.
- Make sure employees know the door is open for any workplace matters. Don't hesitate to have supervisors remind employees about why the dealership is a good place to work and why a union isn't necessary.
- Keep WANADA informed as to any union activity or further developments.

REGULATORY UPDATE: GOOD NEWS FOR DEALERS

Clarification to Regulation Z Requires Only One Copy of RISC to Customers

As dealers well know, since June 2000 the *Polk v. Crown Auto* decision has been a troubling one for dealers. Consumer lawyers have contended that the decision requires a dealer to give two copies of the Retail Installment Sale Contract (RISC) to a customer, an unexecuted version the customer can keep and an executed version after the deal is consummated.



WANADA has been alerted by its government relations advisors, Charapp, Deese & Weiss, LLP, that the Federal Reserve Board issued a clarification to Regulation Z on April 9, 2002, effective immediately, which makes clear that creditors *are not* required to give the consumer two separate copies of the RISC before consummation. It is enough if the creditor gives a copy of the RISC containing the disclosures to the consumer to review and sign, and the consumer receives a copy when the consumer becomes obligated.

The revision makes several additional issues clear:

- It is not enough merely to show the document to a consumer. The consumer must have a chance to review it.
- The consumer must be free to take possession of the RISC to review it before signing. This means that if the customer requests a copy so that the customer can leave and review it, he or she must be given an opportunity to do so.
- Finally, the commentary emphasizes that it is not enough to send a copy of the contract to the consumer sometime after execution. The copy must be given to the consumer upon consummation. Questions about these requirements can be directed to Michael G. Charapp, (202) 463-9100.

NADA Applauds New OSHA Ergonomics Plan

NADA is praising the recently unveiled OSHA ergonomics plan that it says mirrors a proposal advocated by the association.

"This plan is a major improvement over the rejected old rule because it will prevent ergonomics injuries before they occur," said Labor Secretary Elaine Chao. The "comprehensive four-pronged plan" to reduce workplace musculoskeletal (ergonomic) disorders will target high-hazard industries and violators, provide extensive outreach and assistance to small businesses and be based on scientific research. OSHA is unlikely to focus on dealerships or employers making good faith efforts to reduce ergonomic hazards.

The components of the plan are nearly identical to those NADA advocated in testimony and comments to the agency. "The plan should provide dealers access to up-to-date information on best practices designed to achieve effective results, and will give them the flexibility they need to implement innovative workplace safety programs," said Douglas Greenhaus, NADA director of environment, health and safety.

"HOT" NEWS:

Kidney Foundation Chili Cook-Off, May 18

Auto dealers are invited to participate in the 23rd Annual DC Championship Chili Cook-Off, to be held on Saturday, May 18, along Pennsylvania Avenue in Washington, DC, between 14th Street and the FBI Building. The National Kidney Foundation of the National Capital Area sponsors the annual event, which, last year drew over 25,000 people and raised a record \$725,000 to help fund medical research into kidney disease and treatment, patient and community services, professional and public education, and organ donation programs. The goal this year is to be the first chili cook-off in history whose goal is to raise over \$1,000,000 in a single day.

An added attraction this year will be automotive racing and design legend Carroll Shelby, who will serve as Grand Marshall of the event. Shelby, a heart and kidney transplant recipient, founded the concept of chili cook-offs back in 1967. He also founded the Carroll Shelby Children's Foundation, a tax-deductible fund to help indigent children with heart or kidney problems. His professional accomplishments are many: the only American ever to have won the prestigious Le Mans race in 1959; designer of the fabled Cobra in the 1960s, "Shelbyized" Ford Mustangs and Dodge Chargers and, more recently, Chrysler's sensational performance car, the Viper – all of which will be on display at the chili cook-off. In 1992, Carroll Shelby was inducted into the Automotive Hall of Fame, and is still making automotive history with his new Shelby Series 1 sports car.
