
The automobile industry was a career choice that Korengold never regretted. As a student at Trinity College in Hartford, Ct., Korengold recalls, "I was undecided about

WANADA Stages Briefing on Negative Equity

With more and more vehicle buyers coming to the marketplace with vehicles to trade that are encumbered with debt, the issue of negative equity is becoming an important consideration in today's automobile business. When a consumer brings his trade-in debt into the next vehicle transaction, dealers need to make certain that Truth-in-Lending laws are being observed and that consumer protection laws aren't being violated.

Increasingly, consumer protection regulators and plaintiff's lawyers are looking at dealer sales transactions where financing and trade-ins are involved to see whether the dealership has done everything it is supposed to. In situations where Truth-in-Lending and consumer protection laws have been disregarded, regulators and consumer lawyers can pose problems for dealers.

To get WANADA dealers and finance company representatives on the same page with negative equity, WANADA has scheduled a briefing on the subject for Friday, Oct 21 at 9:30 am, Kenwood Country Club. WANADA counsel Patrick Kavanaugh will host the presentation by NADA legal department lawyer Paul Metry and dealer lawyer Michael Charapp. In addition to the dealer principal, sales and F&I managers should attend, as should finance company representatives of WANADA's kindred line.

years, and subsequently worked
as a sales manager for the next
three years. In 1978, along with
his partner Major King,
Korengold became the dealer
principal at the newly opened
Ourisman Dodge in Alexandria,
Va. Today he is president of
four dealerships including
Dodge, Ourisman's World of
Ford in Alexandria, and both
Ourisman Fairfax Toyota and
Chantilly Toyota.

Over the years, his dealerships have received numerous awards: Toyota's President's Award for eight years, Toyota's Board of Governors Award, Ford's North American Customer Excellence Award, and Chrysler's Five Star Dealer Award, to name just a few.

Korengold and his wife, Martha Dippell, are longtime supporters of several educational, charitable, and community institutions. They have established endowments to enrich the lives of others with many of the organizations they have been associated. These include The Washington Performing Arts Society, The National Rehabilitation Hospital (NRH), The National Museum of Women in the Arts, Norwood School, Holton-Arms School, and the Boys and Girls Club of Greater Washington, which honored Korengold with its National Service to Youth Award in 2004 for his tireless efforts on the Club's Capital Campaign Committee.

Korengold is currently

chairman of The Washington Performing Arts Society, serves on the Board of Governors at the Chevy Chase Club, is a trustee of NRH, the Boys and Girls Club, and WANADA. He previously was president of The Historic George Town Club, treasurer of Traveler's Aid Society and finance chair of The National Child Research Center. He is very proud of his family's involvement with the establishment of The Betty Lou Ourisman Breast Cancer Center at The Lombardi Institute at Georgetown Hospital.

Both Korengold's and his wife's lengthy resumes of participation in many other local charities seem to give them little time to spend with their four children, but that is not the case. "Last winter was a little tough. The four kids played on six different ice hockey teams, but we survived," he said.

Education has been a particular interest of Korengold. He served as Chairman of the Board of Trustees of Norwood School in Potomac, MD, has been active with his alma maters. Landon School in Bethesda, MD, and Trinity College, where he was a trustee of The Board of Fellows, a member of The National Alumni Association, and president of The Trinity Club of Washington. His wife is a trustee emerita of The Holton-Arms School in Bethesda

WANADA nominated Korengold in 2001 for The Northwood Dealer Education Award." Education is one of the most important components of a healthy society. Its benefits are far reaching and multigenerational," said Korengold.

Increase in CAFE Unlikely

A proposal by Senate
Energy and Natural Resources
Chairman Pete Domenici (R-NM)
that Congress raise the Corporate
Average Fuel Economy (CAFE)
standards on new cars and trucks
is unlikely to gain much steam,
already suffering "little traction in
the Senate and an absolute
rejection in the House," reports
Capitol Hill's Roll Call
newspaper.

Both Domenici and Sen. Larry Craig, another recent supporter of increasing CAFE, say the proposal is a long shot.

"There may need to be some regulatory adjustment [to CAFE], but that comes with a price," Craig said, citing the need to couple any increases in CAFE standards with measures that also increase oil production.

"You have to see what you can put it together with," Domenici said of the deal-making that is to come. "I'm working on it, but it's hard to work because it's dealing with three different committees."

HURRICANE RELIEF UPDATE

NADA Hurricane Relief Fund Still Needs Donations

NADA and state and metro dealer associations, as well as individual dealers, have donated or pledged more than \$2 million thus far to the Emergency Relief Fund of the National Automobile Dealers Charitable Foundation. But relief requests have outpaced resources, and NADA says "it is imperative that those who have pledged contributions send them in as soon as possible."

The Fund has already distributed \$1.5 million to dealership employees. Employees in Mississippi have received checks, and through Cardinal Bank, the Fund is giving employees in Louisiana \$500-\$1,500 gift cards, based on level of need. "Our goal is to help affected dealers and their employees get back on their feet as soon as possible, and these cards are one more important step toward that goal," said NADA chairman Jack Kain, who last week, with NADA President Phil Brady, toured the affected areas.

Truck Dealers Shift Spring Convention from New Orleans to Atlanta

NADA's 2,400-member American Truck Dealers (ATD) announced that it has switched its April 22-24, 2006 convention and exposition from New Orleans to the Georgia World Congress Center in Atlanta. The medium-and heavy-duty trucks dealer group cited the devastation to New Orleans from Hurricane Katrina as the reason for the switch, but said it would return to New Orleans as soon as possible. NADA held its 2005 convention in New Orleans and is not due to return to the city until 2009. No change in those plans has been announced.

AIADA's online temporary job bank for dealership employees displaced by Hurricane Katrina had posted over 1,100 temporary job openings in nearly every state as of last week. 
AIADA's "Rev-Up America" to Launch Next Week
