

# Register for WANADA's Flu Shot Program for Dealer Employees Before August 31

Registration is now open for WANADA's seasonal flu shot program for dealership employees.

Once again, WANADA's flu shot program will be available on-site at WANADA dealerships and administered by Norvar Health Services. The on-site service will be available for adults aged 18 and older.

The fee will be \$33 for the vaccine with a minimum of twenty (20) participants required at each location. Locations with less than 20 participants will be billed as if 20 doses of vaccine were administered. The difference will be billed at a rate of \$26 per dose.

As usual, adults 65 and older have a choice of getting the high-dose flu shot, which offers better protection against the flu compared with the regular shot. The fee for the high-dose shot will be \$75. Human immune defenses become weaker with age, which places older people at greater risk of severe illness from influenza. In addition, aging decreases the body's ability to have a good immune response after getting influenza vaccine. A higher dose of antigen in the high-dose vaccine gives older people a better immune response against the flu. Data have shown that that leads to greater protection against influenza.

To have your dealership participate, please register online at <a href="www.norvarhealthservices.com">www.norvarhealthservices.com</a>, under "Scheduling". Alternatively, you may call Norvar at 202-744-1360. Given the popularity of this program, you are encouraged to register early to guarantee the date of your choice. Any request received after August 31 may be subject to vaccine availability.

Norvar Health Services will begin conducting on-site visits starting October 1. All scheduling will be done by Norvar upon submission of your registration. Norvar will contact the dealer's designated representative with the scheduled date/time and forward all appropriate forms. Norvar will invoice the dealership directly for all flu shots administered via the program, subject to the 20 dose-minimum.

#### Reminder: Va. Overtime Wage Act Takes Effect July 1

As of next week, <u>Virginia's Overtime Wage Act</u> will be in effect, imposing new state standards for calculating overtime pay that differ somewhat from the <u>Fair Labor Standards Act</u>, particularly for <u>non-exempt</u> employees who are paid on salary or another fixed basis. Under the new law, Virginia employers must calculate a non-exempt salaried employee's hourly overtime-eligible wage as 1/40<sup>th</sup> of their total wages paid for a workweek, defined as any seven consecutive days. That portion of the law does not seem to include any kind of exemption for other amounts generally excluded from the regular rate under FLSA; the law does note the exemption when describing the OT-pay calculations for non-exempt workers who are explicitly paid hourly.

In addition, the law affords employees up to three years to file claims for back wages, if they believe their employer underpaid them, and establishes an 8-percent interest charge for any back

wages that a court determines the employer owns. As of last July, Virginia employers can, for the first time, file a civil suit on their own in a state court, and this bill provides for collective or class-action suits. Historically, the ability to file class-action lawsuits in state court has been heavily restricted in the commonwealth.

In addition, if a non-exempt employee is misclassified, the new Virginia law appears to entitle a successful claimant to recover not just the extra 50 percent hourly wage for any time that they had worked over 40 hours, but to fully claim the entire time-and-a-half for all hours worked over 40 in a week while they were misclassified.

### Beltway/I-270 HOT Lane Plan Hits Another Major Snag

Earlier this year, Maryland Gov. Larry Hogan announced that the state was planning to drastically scale back an original plan to widen most of the Maryland side of the Beltway and also Interstate 270, to just focus on adding HOT lanes from the American Legion Bridge on the Beltway up to Gaithersburg. Now nearly four years after the governor unveiled the original widening plan, even the scaled-back version may be doomed after a local planning board voted

to halt a federally-required environmental study necessary for the project to go forward.

The region's Transportation Planning Board, comprised of state, county, and local officials from the District, Maryland, and Virginia, voted earlier this month to halt a study that would examine the environmental impact of the plan to expand the American Legion Bridge and add HOT lanes to I-270. The move to kill the study, which likely halts the highway plan entirely for now, was supported by representatives from D.C., Arlington, Alexandria, and many Maryland localities.



Both Maryland and Virginia's state-appointed representatives on the board opposed the measure to halt the environmental study, as did representatives from Gaithersburg and Frederick. Virginia has added HOT lanes to nearly all of their portion of the Beltway in recent years as part of a larger plan supported by every governor since Mark Warner held the job nearly two decades ago. The HOT lanes have created chokepoints on the Legion Bridge at the state border. Maryland controls nearly the entire Potomac River, and, as result, the Legion Bridge.

As it stands now, Maryland state officials believe the move jeopardizes an agreement between Hogan and Gov. Ralph Northam to rebuild the aging bridge, not to mention the HOT lanes that, if built, would essentially connect northern Montgomery County all the way with areas south of the Occoquan River. The overall highway plan, which Hogan first announced in 2017, would have also added HOT lanes on nearly the entire Beltway, from the Legion Bridge all the way to State Route 5 (Branch Avenue) in Suitland.

### DC DMV to Resume Walk-in Services for the Public on July 19

The DC DMV announced yesterday that it will offer walk-in appointments at all service centers beginning on Monday, July 19. As part of the transition period, residents can still make specific appointments for any available date until that system closes on July 17. Earlier this month, the DMV announced that the grace period for IDs and driver's licenses has been extended until Sept. 9. Previously, all expired IDs and licenses needed to be renewed by July 1.

The DC DMV noted that the grace period for expired inspections and vehicle registrations ended back on June 1 and will not be extended. The DMV is extending hours at the inspection center at 95 M Street SW on select Saturdays and Sundays between now and mid-July, and there is a self-service kiosk in Takoma that is open 24/7.

# John O'Donnell Attends Dealer Fundraiser for Md. Comptroller Candidate Brooke Lierman
